EXECUTIVE SUMMARY

Shape Attitude Ghana celebrated its fifth anniversary in June 2019 with the event marked by a durbar at the Jophus Anamoah-Mensah Conference Centre at the University of Education, Winneba. On the occasion of the fifth anniversary, prizes were awarded to schools that came on top of the 2018/2019 Stay Clean Competition in Winneba schools. Twenty-nine schools participated in the competition. The sensitisation and awareness campaign as well as the competition have contributed immensely to cleanliness on compounds of most schools in Winneba.

Through SHAPE Attitude Ghana, Mr Asamoah, Executive Chairman of A&C Development Company and President of GAFICS donated ten computers to Winneba schools, two to SHAPE Attitude Ghana and one to Radio Peace, Winneba.

In the area of personnel, the National Service Scheme assigned a service personnel to SHAPE Attitude Ghana in September 2019 to replace the one whose assignment ended in August 2019. The Organisation joined the Scheme to five tertiary institutions for the orientation of Service Personnel.

Radio Peace FM in Winneba and Radio Windy Bay of the University of Education, Winneba continued to be advocates of educational and sensitisation messages on sanitation to the public and this contributed immensely to the gains achieved so far.

In order to maximise the limited resources available to SHAPE Attitude Ghana, the Organisation restricted its activities to schools in 2019. Nonetheless, discussions were held with heads of the fishing communities in Winneba and Apam with a view to initiating sensitisation and awareness campaign in their communities. SHAPE Attitude Ghana joined hands with the Department of Theatre Arts, Winneba to undertake sensitisation and clean-up campaigns at Osubompayin and Yepemso suburbs of Winneba. A similar activity was undertaken at Apam with SACOST-UEW. There was also collaboration with Coast for Christ Ministries during their medical screening exercise at Yepemso and Wheda.

As a usual practice of the Organisation, the accounts for 2018 were audited and annual returns submitted to the Registrar General's Department before the deadline of end April 2019. Similarly, the NGO certificate issued by the Department of Social Welfare was also renewed in the first quarter of 2019.

Shape Attitude Ghana a not-for-profit organisation was established in June 2014. It is committed to enabling communities develop a culture of keeping their surroundings clean all the time. The Organisation has been working mainly in schools to address negative attitude in the hope that children aged four to fifteen years in schools will grow up with positive attitude towards sanitation and the environment in general.

SHAPE ATTITUDE GHANA 2018 ANNUAL REPORT

1. Introduction

SHAPE Attitude Ghana celebrated its fifth anniversary in June 2019, an event that was marked by a durbar to award winning schools of a competition organised by the organisation. The competition presented an opportunity to assess the impact of the sensitisation campaign on indiscriminate littering and disposal of refuse being pursued by SHAPE Attitude Ghana.

Informal assessment of the success of the awareness campaign indicates that the project has made an impact in some schools and the overall cleanliness in some parts of Winneba town. School authorities and some opinion leaders have attested to the fact that sensitisation and awareness campaigns on littering in schools have impacted positively on the school pupils.

The report presents progress and achievements on implementation of activities. It also looks at finances, challenges and future perspectives.

2. Implementation of activities

2.1. Fifth anniversary of SHAPE Attitude Ghana

In June 2019 SHAPE Attitude Ghana celebrated its fifth anniversary. The major activity organised to mark this event was the award for winners of the Stay Clean Competition organised for the basic schools in Winneba. The event which took place at the Jophus Anamuah-Mensah Conference Centre, University of Education, Winneba, was attended by almost eight hundred school pupils and their teachers. The Chief of the Effutu traditional Area, Neenyi Ghartey VII graced the occasion as the chairperson. Also present were representatives of the Ghana Education Service from Effutu Municipality and Apam District, the A&C Development Company led by Andrew K. Asamoah Jr, the Ghana Association of Former International Civil Servants (GAFICS) and the Environmental Health Office, Winneba.

The University was represented by Professor Kolawole Raheem, Head of the Centre for School and Community Science and Technology Studies (SACOST-UEW).

2.2. Competition on cleanliness and presentation of Awards

A competition on cleanliness was launched in June 2018 for schools that have had sensitisation and awareness campaigns from SHAPE Attitude Ghana. The criteria for assessment were litter free compounds, no weedy surroundings, well kept flowers, availability of trash bins at

vantage points and presence of trees. Other criteria were litter free surroundings within 50 to 100 meters radius from the school, clean gutters and no overgrown weeds. The winning schools were awarded with plaques and certificates. All participating schools were given certificate of participation, trash bins and exercise books.

2.3.Orientation of National Service personnel

SHAPE Attitude Ghana joined the National Service Scheme for the orientation of final year students in tertiary institutions in the Central Region. The service personnel were tasked to become agents of change on sanitation and promote good sanitary practices when they go out to their stations or work places. The orientation took place at University of Education, Winneba; University of Cape Coast, College of Community Health Nursing (CCHN) Winneba, Cape Coast Technical University (CCTU), Perez University Winneba and Ankaful Nursing College.

2.4.Exercise with Theatre Arts Final Year Students

Since 2016, SHAPE Attitude Ghana has supported final year students of Theatre Arts from the University of Education, Winneba on their project work relating to sanitation. In 2019, the students undertook their project at Osubonpayin, a village near Winneba. SHAPE Attitude Ghana supported the students with posters, trash bins for the community and food items to support the students' stay in the village. The Organisation also took part in their clean-up campaign and sensitisation talks in the village as well as facilitation of quiz and debate competition with the Ampah Preparatory School at Osubompayin.

2.5.Joint activities with Coast for Christ Ministries

- i. While Coast for Christ Ministries was undertaking medical screening, SHAPE Attitude Ghana gave sensitisation and awareness talks and participated in a clean-up exercise at Yepemso and Winneba landing beach with the fisherfolks.
- ii. Sensitisation and awareness talks on ensuring good sanitary conditions by SHAPE Attitude Ghana alongside supply of water purification products to the people of Hweda by Coast for Christ Ministries.

2.6.Apam Project

SHAPE Attitude Ghana was invited to the launching of "Making Apam the cleanest City" by the Gomoa West District Assembly, SHAPE Attitude Ghana joined the town folks on their clean-up exercise at Apaa Paado in Apam. This was followed by sensitisation and awareness talks in nine schools in Apam.

2.7. Media

All the three radio stations in Winneba, Radio Peace, Radio Windy Bay of UEW and NYCE FM of Challenging Heights, accorded SHAPE Attitude Ghana free airtime to disseminate information on good sanitary practices. The dissemination took the form of panel discussions, daily messages on stopping littering on Radio Peace and coverage of events organised by the Organisation.

3. Audited accounts and renewal of licences

3.1 Audited accounts

During the first quarter of 2018, the audited accounts of 2017 were completed by B Omane-Antwi Consult, Chartered Accountants and the annual returns submitted to the Registrar General's Department in the same quarter

3.2 Renewal of licenses/certificates

3.2.1. Registrar General's Department

Returns to the Registrar General's Department were submitted before the deadline of end April 2019.

3.2.2. NGO certificate

The Organisation renewed its NGO certificate with the Department of Social Welfare in the first quarter of 2019.

4. Reporting

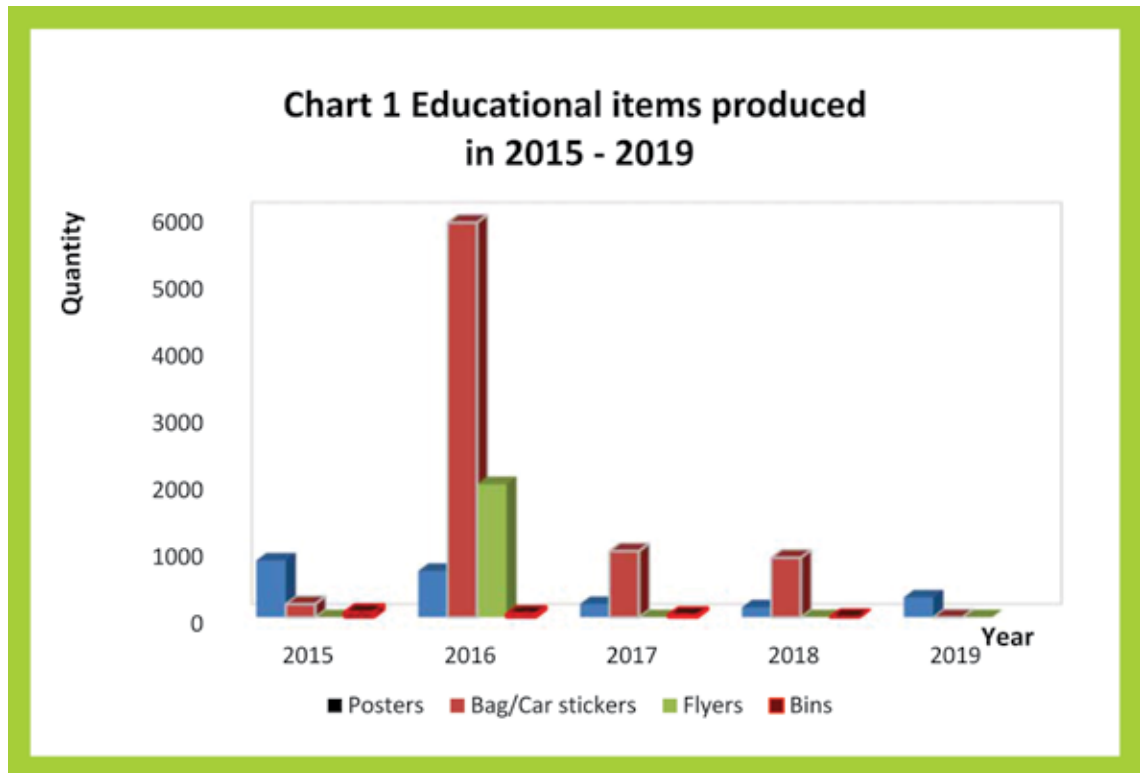
Annual implementation report, preparation of financial statements for auditing and annual audit report were all completed within the first quarter of 2019.

5. Acquisition of equipment and other materials

Mr Andrew Asamoah through GAFICS donated two computers to SHAPE Attitude Ghana. A request by SHAPE Attitude Ghana to Mr Asamoah and GAFICS for computers to be supplied to Winneba Schools and Radio Peace was fulfilled. The schools received ten computers and one to Radio Peace.

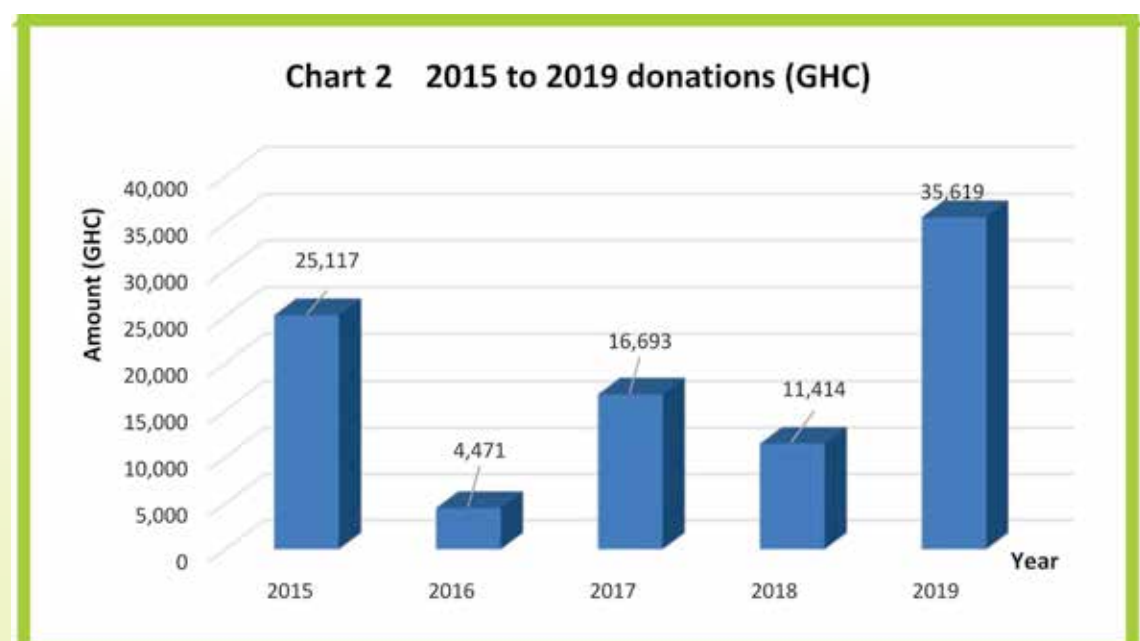
SHAPE Attitude Ghana purchased one UPS for its office for installation of the computers donated by GAFICS.

In terms of educational materials, just 350 posters were produced and fifty trash bins purchased for the awards.

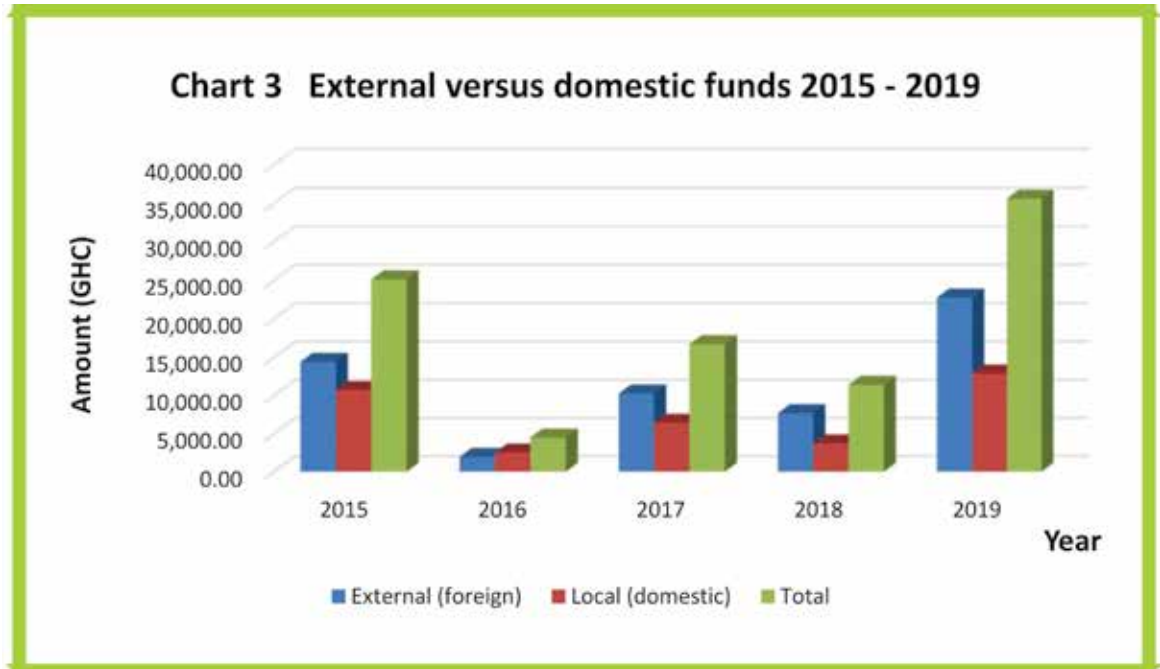


6. Funding

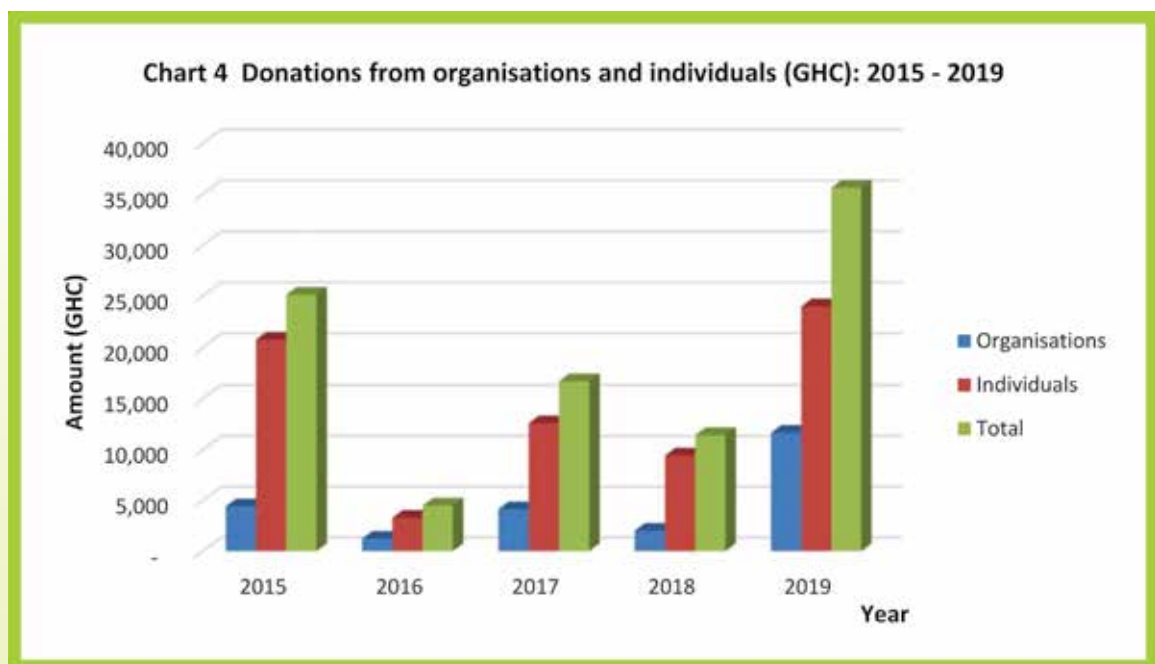
Donations received in 2019 came to GHC35,619 as against GHC11,414 in 2018. The 2019 donations is the highest received in the life time of the Organisation. Most of the donations received was to support the school cleanliness competition and 5th Anniversary celebration activities. Chart 2 shows the amounts received between 2015 and 2019 and annex 5 shows the list of donors in 2019.



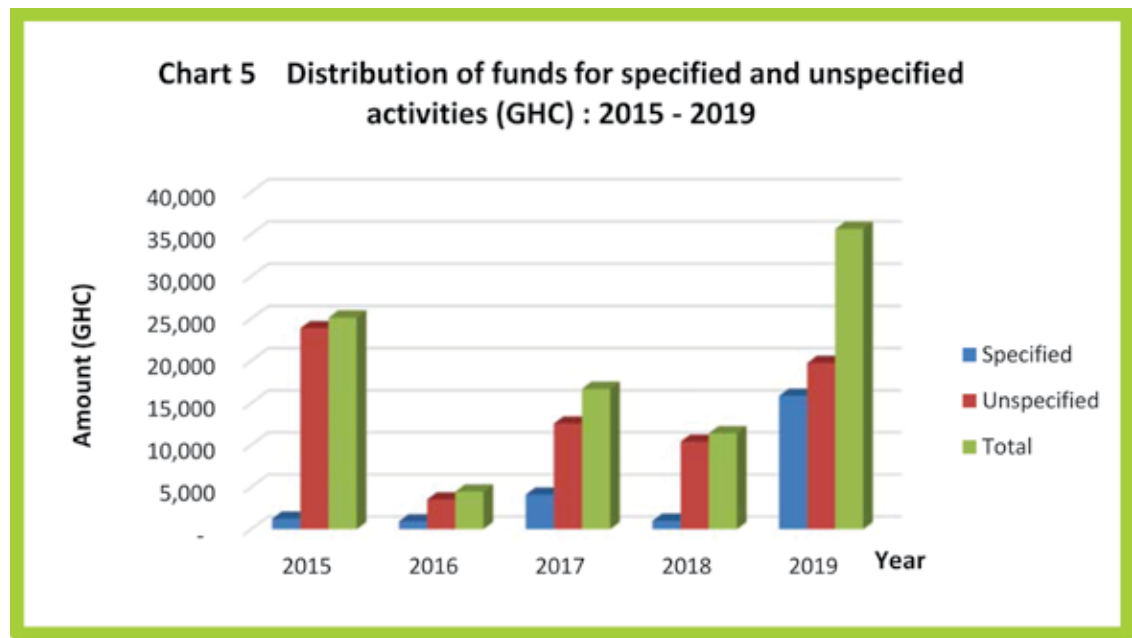
External funding was the main source of funding without which it would have been a big challenge in running the project. Sixty-four per cent of the 2019 donations came from external sources and 36 per cent from domestic sources. This followed the 2018 pattern where 67 per cent was from external source and 33 per cent from domestic source. Chart 3 shows the external and domestic sources of funding from 2015 to 2019.



Funding of the Organisation in 2019 was mainly from individuals as has been the case since the inception of the project. Contributions from individuals constituted 67 percent of the total and organisations 33 percentage. In 2018, contributions from individuals constituted 82 percent with 18 percent from organisations. Refer to chart 4.

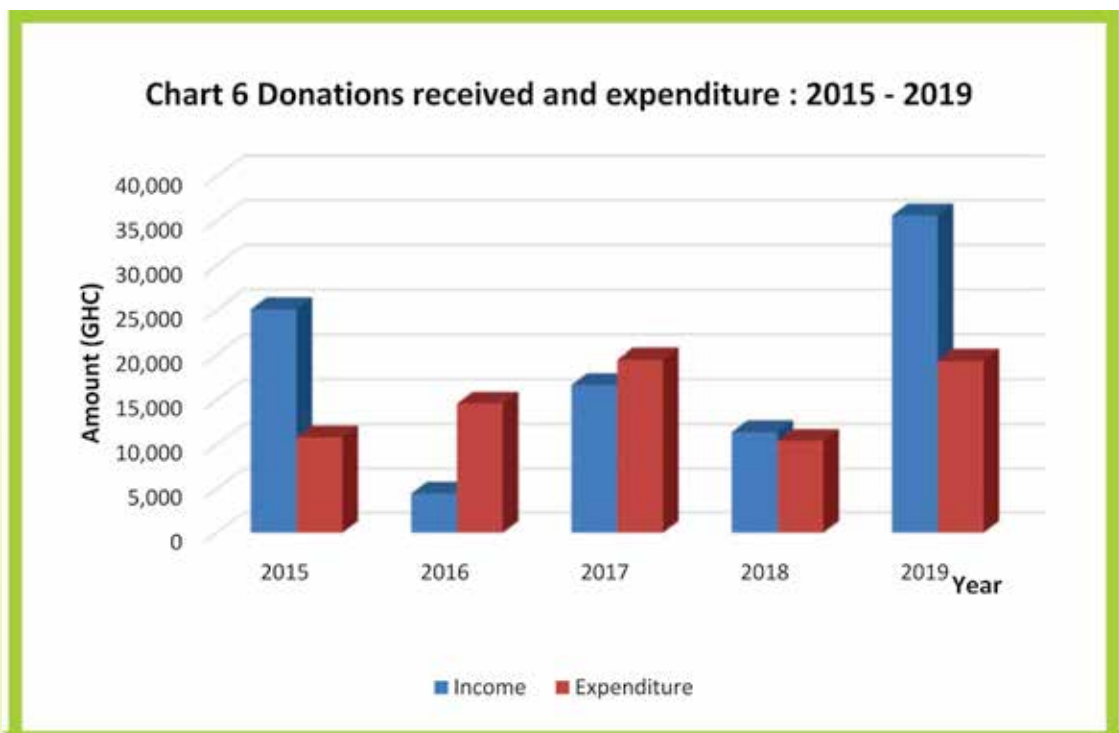


There was an increase in the funds tied to activities (specified donations) in 2019 compared to 2018. The percentage share of the funds tied to activities was 45 percent in 2019 as against less than nine per cent in 2018. The increase of funds tied to activities in 2019 was due to donations made to support the School Cleanliness Competition and celebration of the 5th Anniversary of SHAPE Attitude Ghana. Chart 5 shows the distribution from 2015 to 2019.

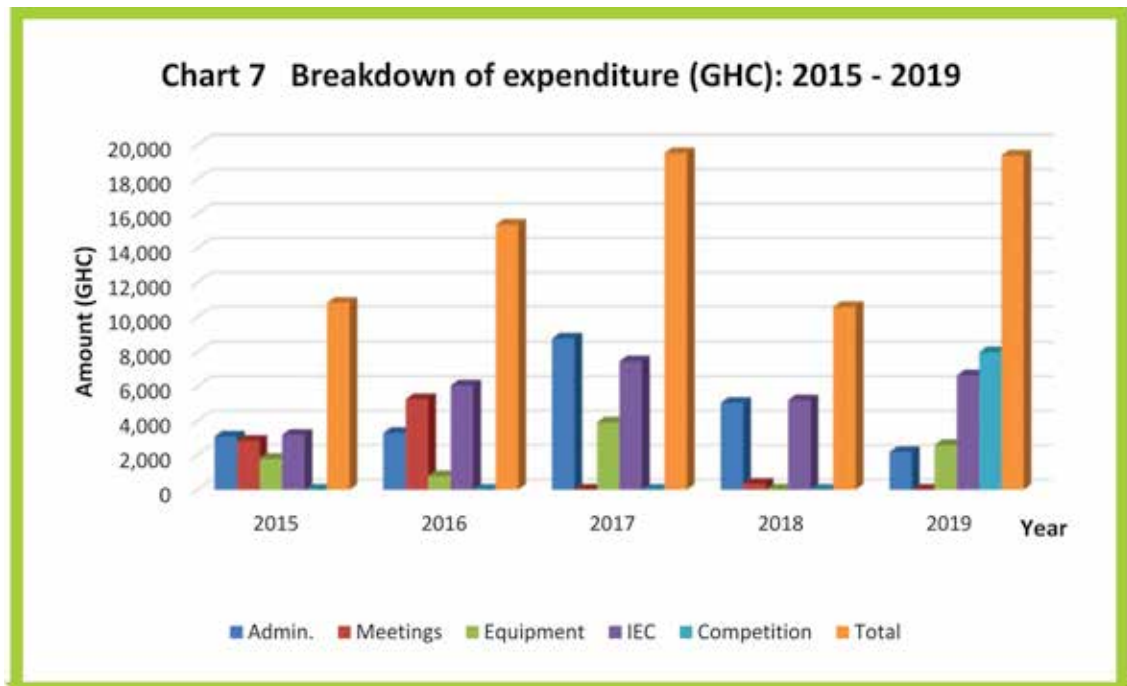


7. Donations received and expenses incurred

In 2019, an amount of GHC35,619 was received as donation and expenditure came to GHC19,373 compared to 2018 donation of GHC11,414 and GHC10,565 expenditure.



There were donations in kind of computers made by Mr Andrew K Asamoah through GAFICS. The University of Education, Winneba gave their conference centre free of charge for the Award Ceremony and 5th Anniversary durbar.



8. Challenges

Collaboration with some key stake holders was not up to the level expected yet this is one of the main factors that could help to accelerate achievement of expected results.

Inadequate material and financial resources have also been limiting factors that have constricted progress with implementation of activities. Much of the needed financial support came at the tail end of the year and could therefore not be applied before the close of the year.

Irregular and untimely emptying of bins by the relevant authorities have not helped with the sensitisation messages to the public.

The seemingly indifference of some opinion and political leaders has not helped the course of promoting environmental cleanliness.

1. Conclusions

Five years into its operations, SHAPE Attitude Ghana has impacted positively on most of the school pupils who have had interaction with the Organisation and its sensitisation messages. The competition organised for the schools helped in promoting good sanitary practices, especially littering on the school compounds which are neat with little or no litter. A significant success story is where no littering takes place on the compound of Anglican 'A' Primary School. The pupils on their own initiative have used card boxes as litter bins and placed them at strategic points on the compound. They also voluntarily pick plastics that have been blown by wind unto their compound. Above all the pupils confront anyone who litters on their compound.

Although provision of adequate infrastructure such as trash bins at vantage points and dumping sites is said to help reduce littering and indiscriminate dumping, experience on the ground increasingly shows that without enforcement of bye laws on sanitation, it will take much longer time to achieve the attitudinal or behavioural change. Community sensitisation, surveillance and indeed community sanctions would be helpful.

SHAPE Attitude Ghana will continue with its effort towards increased collaboration with other stakeholders. It will also continue explore possibilities of getting the authorities to enforce sanitation bye-laws as a way of accelerating attitudinal change.

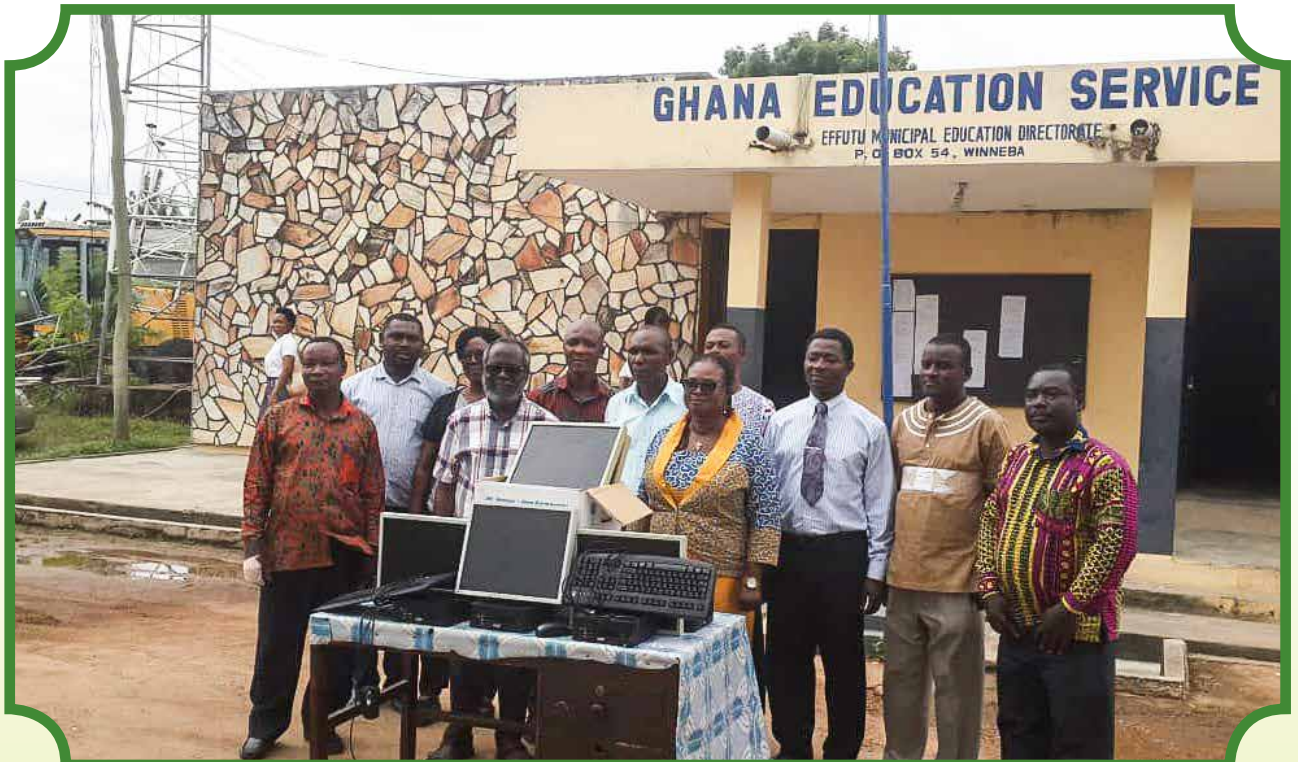

Report of the directors

Shape Attitude Ghana a not-for-profit organisation which was established in June 2014, is committed to enabling communities develop a culture of keeping their surroundings clean. The Organisation has been working mainly in schools to address negative attitude in the hope that the school children will grow up with positive attitude towards sanitation and the environment in general.

Shape Attitude Ghana celebrated its fifth anniversary in June 2019 with the event marked by a durbar at the Jophus Anamoah-Mensah Conference Centre at the University of Education, Winneba. On the occasion of the fifth anniversary, prizes were awarded to schools that came on top at the 2018/2019 Stay Clean Competition in Winneba schools which twenty-nine schools participated. The sensitisation and awareness campaign as well as the competition have contributed immensely to cleanliness on compounds of most schools in Winneba.

Nine schools in Apam and one in its suburb were visited and sensitisation and awareness messages given to them.

Through SHAPE Attitude Ghana, Mr Asamoah, Executive Chairman of A&C Development Company and President of GAFICS donated ten computers to Winneba schools, two to SHAPE Attitude Ghana and one to Radio Peace, Winneba.

In the area of personnel, the National Service Scheme assigned a service personnel to SHAPE Attitude Ghana in September 2019 to replace the one whose assignment ended in August 2019.

Radio Peace FM in Winneba and Radio Windy Bay of the University of Education, Winneba continued to be advocates of educational and sensitisation messages on sanitation to the public and this has contributed immensely to the gains achieved so far.

In order to maximise the limited resources available to SHAPE Attitude Ghana, the Organisation restricted its activities to schools in 2019. Nonetheless, discussions were held with heads of the fishing communities in Winneba and Apam with a view to initiating sensitisation and awareness campaign in their communities. SHAPE Attitude Ghana joined hands with the Department of Theatre Arts, GRASAG and WAPS all of University of Education, Winneba to undertake sensitisation and clean-up campaigns at Woarababa and Yepemso suburbs of Winneba. A similar activity was undertaken at Apam with SACOST-UEW.

As a usual practice of the Organisation, the accounts for 2018 were audited and annual returns submitted to the Registrar General's Department before the deadline of end April 2019. Similarly, the NGO certificate issued by the Department of Social Welfare was also renewed in the first quarter of 2019.

Executive councils' responsibilities


The executive council is responsible for the preparation of the financial statements for each financial year, which give a true and fair view of the state of affairs of the organisation and of its excess or deficit of operations and the cash flows for the period and the financial position. In preparing these financial statements, the executive council has selected suitable accounting policies and applied them consistently, made judgments and estimates that are reasonable and prudent and followed Ghana Accounting Standards.

Also, the executive council is responsible for ensuring that proper accounting records that disclose with reasonable accuracy at any time the financial position of the organisation, safeguards its assets and taking reasonable steps for the prevention and detection of fraud and other irregularities.

Accounting policies and explanatory notes
to the financial statements
for the year ended December 31, 2019

1 General information

Shape Attitude Ghana Organisation is a private company limited by guarantee incorporated in Ghana to carry out sensitization on sanitation in the communities for clean environment. It has its registered office and principal place of business situated at #E3/2, Winneba, near Trauma Hospital Ntakorfam in Winneba.

2 Basis of preparation and accounting policies

These financial statements have been prepared in accordance with the Ghana Accounting Standards. They have been prepared under the historical cost convention and in Ghana Cedi (GH¢) currency.

(a) Revenue recognition

Revenue are generally donations received from individuals. They are not restricted in any way whatsoever. It is recognised only when donation is actually received. Pledges are noted but are not recognised as revenue until the actual receipt thereof.

(b) Income tax

The organisation is a Not-for-Profit company. It does not carry out any activity with the intention of making profit or earning an income which will be liable to Income Tax as defined by Law.

(c) Property, plant and equipments

Items of plant and equipments are measured at cost less accumulated depreciation and any accumulated impairment losses. Depreciation is charged so as to allocate the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The following annual rates are used for the depreciation of items of equipments:

During the year under review, the organisation bought fuel for the use of the motor vehicle of one of its executive council members for its operations. This expense has been classified as transport charge.

(f) Accounts payables

Accounts payables are obligations on the basis of accrued and other operating expenses for which settlements are delayed.

(g) Cash and cash equivalents

For the purposes of the statement of cashflows, cash and cash equivalents comprise of cash on hand, deposits held at call with banks, other short-term investments and bank overdrafts.

(h) Foreign currency translation

The functional currency of the organisation is Ghana Cedis (GH¢). Other currency transactions

are accounted for at the exchange rates prevailing at the dates of the transactions.

(I) Comparative figures

The comparative figures covered the twelve months period ended December 31, 2018. However, where considered necessary, comparative figures have been reclassified to achieve consistency with the presentation of current year figures.
